From East:

Take I-64 West
Take the I-95 SOUTH/5TH. STREET exit number 190, on the left towards
PETERSBURG/DOWNTOWN/COLISEUM.
Stay straight to go onto N. 5TH ST.
Turn LEFT onto E. CARY ST.
Go PAST S. 9TH St.
SunTrust Customer Parking lot is located on the left, under the SunTrust Center.

From South:

Take I-95 N/RICHMOND PETERSBURG TURNPIKE.
Take the VA-195 TOLL/DOWNTOWN EXPRESSWAY exit, exit number 74A,
towards (I-195).
Take the CANAL ST. exit towards (US-60).
Merge onto E CANAL ST.
Turn RIGHT onto S 9TH ST.
Turn RIGHT on E CARY ST.
SunTrust Customer Parking lot is located on the left, under the SunTrust Center.

From West:

Take I-64 EAST
I-64 E becomes I-64 E/I-95 SOUTH
Stay straight onto RICHMOND PETERSBURG TURNPIKE/I-95 SOUTH
Take the FRANKLIN ST. exit, exit number 74B.
Turn RIGHT onto E FRANKLIN ST.
Turn LEFT onto N 14TH ST.
Turn RIGHT onto E CANAL ST.
Turn RIGHT onto S 9TH ST.
Turn RIGHT on E CARY ST.
SunTrust Customer Parking lot is located on the left, under the SunTrust Center.

From North:

Take I-95 SOUTH
Take the FRANKLIN ST. exit, exit number 74B.
Turn RIGHT onto E FRANKLIN ST.
Turn LEFT onto N 14TH ST.
Turn RIGHT onto E MAIN ST.
Turn LEFT onto S 8TH ST.
Turn LEFT on E CARY ST.
SunTrust Customer Parking lot is located on LEFT on the corner of S 9TH ST, under the SunTrust Center.
